NOTICE IS HEREBY GIVEN THAT the San Carlos Planning Commission will hold a special meeting for a virtual public hearing on **Wednesday, January 12, 2022 at 6:00 PM** for the purpose of hearing and considering all comments of all persons interested in or concerned with the scope of the Environmental Impact Report ("EIR") for the **City of San Carlos** Focused General Plan Update: Housing, Land Use, and Safety Elements and Accompanying Zoning Ordinance Amendments.

The updates to the City's policies related to housing, land use, and environmental safety, including corresponding zoning ordinance amendments are in response to state law mandates to address housing and environmental safety needs. Comments on the scope of the EIR are due by **January 31, 2022, at 5:00 p.m.** All comments regarding the EIR must be made in writing and received by this ending date/time.
